ABOUT GIFT OF ADOPTION:

Gift of Adoption (GOA) is a national 501 (c) (3) charitable organization that provides the final funds needed to complete the adoptions of vulnerable children in the United States and abroad. Since GOA's founding in 1996, \$6.8 million in grants have been awarded and more than 2,275 children have been adopted. GOA grants are awarded to qualified U.S. parents without regard to age, race, religion, ethnicity, marital status or sexual orientation.

To fill the void that separates child from family – through adoption assistance grants that give vulnerable children a permanent home and the chance to thrive.

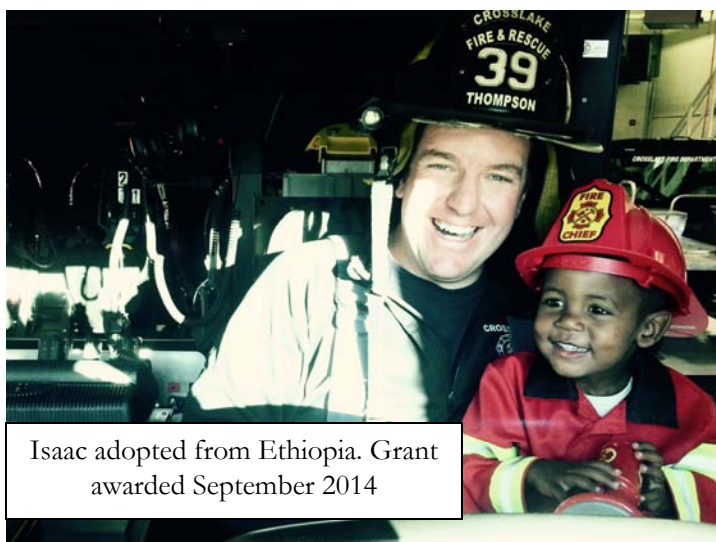
