GIFT OF ADOPTION EVENT WAIVER AND RELEASE OF LIABILITY

- I, in recognition of the risk of injury while participating in the Gift of Adoption Event(s), and in consideration for the rights I am giving to the Event, I hereby do my self, my heirs, executors, administrators, assigns, and personal representatives knowingly and voluntarily accept the risks, nature and extent of liability, Agreement and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the Event, and I hereby release and forever discharge (I understand by affiliates, managers, members, agents, attorneys, employees, volunteers, hosts, representatives, professionals, contractors and agents, facilities and its affiliates, managers, members, agents, attorneys, employees, volunteers, hosts, representatives, professionals, contractors and agents, the event site and its agents, managers, employees, volunteers, hosts, representatives, professionals, contractors and agents and all operators and/or beneficiaries of the Event collectively known from any and all liability, claims, demands, damages, actions or causes of action now existing or which hereinafter may arise as a result of my participation in the Event, whether any injury is caused by the negligence of the Event, the negligence of myself or third parties, the combination of the causes or any other cause.
- I agree to indemnify and hold harmless the Event against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise through by me or anyone on my behalf, including attorneys' fees, if litigation arises as a result of claims made by me or anyone on my behalf.
- I understand that various photographs, video recordings, and other media will be taken during the Event.
