ABOUT GIFT OF ADOPTION:

Gift of Adoption (GOA) is a national 501 (c)(3) charitable organization that provides the final funds needed to complete the adoptions of vulnerable children in the United States and abroad. Since GOA's founding in 1996, \$9.3 million in grants have been awarded and more than 3,176 children have been adopted. GOA grants are awarded to qualified U.S. parents without regard to age, race, religion, ethnicity, marital status or sexual orientation.

Gift of Adoption provides grants to complete the adoptions of vulnerable children - giving them permanent families and a chance to thrive.

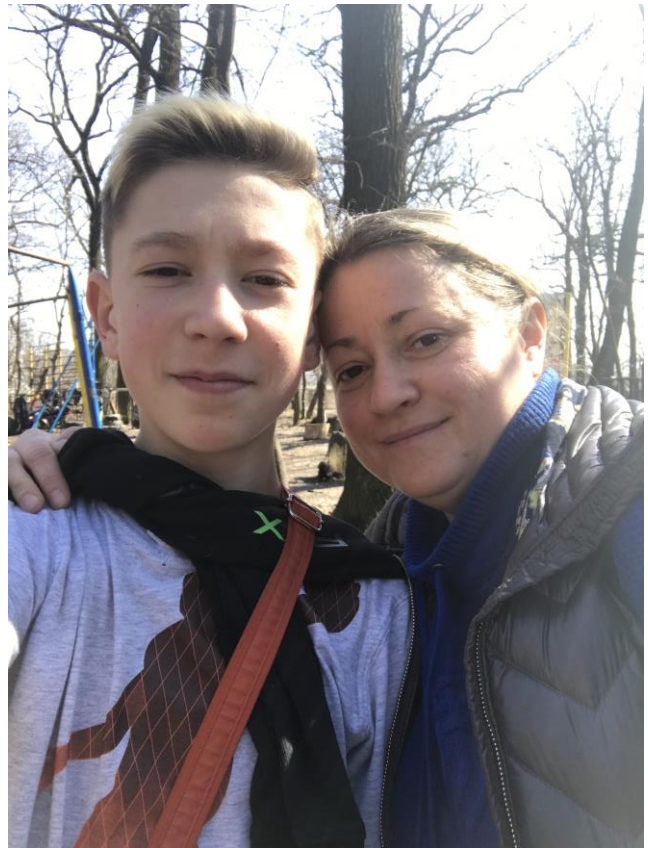
