Dear Friends,

Thank you for taking the time to review the FY22 Annual Report, featuring 2-1/2-year-old Autyme on the cover. We chose this cover photo because undeterred by the Minnesota snow, Autyme was ready to take her bike out for a spin! So out she went.

We love this 'no time like the present' energy because we know that childhood is brief. And for the children we serve, the time for them to get to where they're going **is now.**

To all of you: friends, supporters, partners, and volunteers who played a role in making the gift of adoption possible for Autyme and the 614 other children we served in FY22, we thank you.

As I reflect on my time with Gift of Adoption it has been an incredible journey. Since my first involvement in 2012 when we helped 128 children, to this year in which we are on track to reach 650 children, I have been amazed by the commitment to our mission. From the first grant Gift of Adoption awarded in 1996, that prevented 4-year-old Cristy from entering foster care, to the 5,000th child we're reaching with a grant this year, our sole purpose continues to be awarding grants on a nondiscriminatory basis to complete the adoptions of children in vulnerable circumstances. It is our heritage, and the guidepost for the future.

Your generous support to Gift of Adoption is building a sustainable organization, recognized as "Exceptional" with the highest Four-Star rating by Charity Navigator, and with increased efficiencies and capacity to grow the number and value of grants awarded annually. With your support, \$2,158,616 was awarded in grants last year, an increase of more than \$300,000 compared to 2021.

So, with you, we celebrate the impact made since inception, with \$15,000,000 awarded to unite 5,000 children with their families. Yet we remain focused on growing impact in the future, to address an increasing demand for GOA grants, marked by an increase of 77% in applications received each year since 2018, and a record number already received in this first quarter of 2023.

To scale impact, several initiatives are underway, thanks in large part to the directed donations that fund core operations from our 130 Investor Board and National Board members. We are seeing promising returns from the investment of volunteer and staff time and resources dedicated to developing mutually meaningful corporate partnerships and helping more community and family foundations fulfill their goals through the joining of children with families in their areas. The expansion and development of our chapter networks, now 27 chapters strong, is of tremendous value and importance, with 45% of annual revenues generated through volunteer leaders who are the face and heart of GOA. I am personally so grateful to serve this mission alongside these leaders.

In closing, we thank you for your belief in and support for the children we are privileged to serve. Your engagement made learning to ride a bike -- in the snow, on a quiet cul-de-sac, along with her twin brothers -- possible for Autyme. Reminding us that there is no telling what the gift of family will make possible for Autyme this year, or the next year or the next. But what we can know for sure is that, with their love and support, she is already well on her way.







Last year, Adam Pfeil, President of the Texas Chapter was recognized as an honoree, and Ngozi Okarafor, past Illinois Chapter board member, as congressional nominee.



ADAM PFEIL

Adam is the volunteer president of Gift of Adoption's Texas Chapter and has exponentially increased the number of children helped in Texas each year. Adam brings genuine passion to his work with Gift of Adoption, going out of his way to make meaningful connections with the children and families they serve. Gift of Adoption's Texas Chapter was established in 2014, raising just \$12,500 that inaugural year. Adam became the chapter's president in 2016 and under his leadership the Gift of Adoption Texas Chapter has become one of the most active and successful nationwide. In 2022, the Chapter raised more than \$100,000 with 100 percent of these funds going directly toward local adoption assistance grants.

NGOZI OKARAFOR

Ngozi was passionate about adoption and human rights and worked diligently in the service of others before her untimely death in 2021 at age 48. Ngozi served as a member of Gift of Adoption's Illinois Chapter Board of Directors for 3 years where she worked to raise awareness and funds to complete the adoptions of vulnerable children into permanent, loving families in Illinois. Through her gifts of time, talent, and treasure, Ngozi proved herself a fierce advocate for children in need of families. She served as Chief Legal Counsel for the Illinois Department of Human Rights and was as the Director of Employment Actions for the Cook County Sheriff's Office.



When it became clear that reunification with her birth mother would not be possible, David and Mary began the process of adopting Autyme. As retirees, David and Mary do not have the income they once did and a third adoption was a serious financial strain. A grant from Gift of Adoption helped them complete Autyme's adoption in 2022, ensuring she will grow up in the same safe, loving, and permanent home with her older brothers. David and Mary say, "Autyme is very active, happy, and loves spending time with her brothers!"
