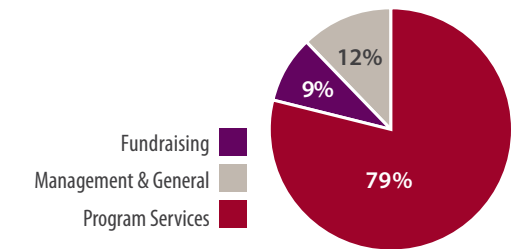

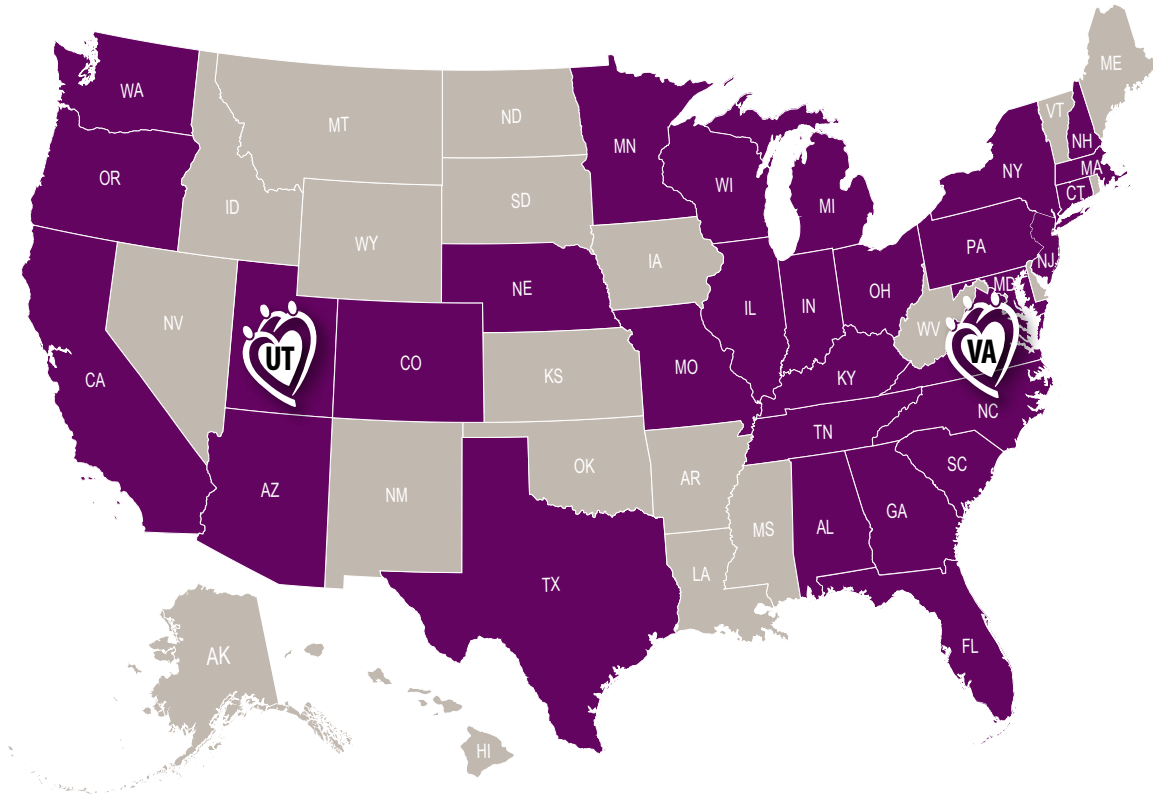

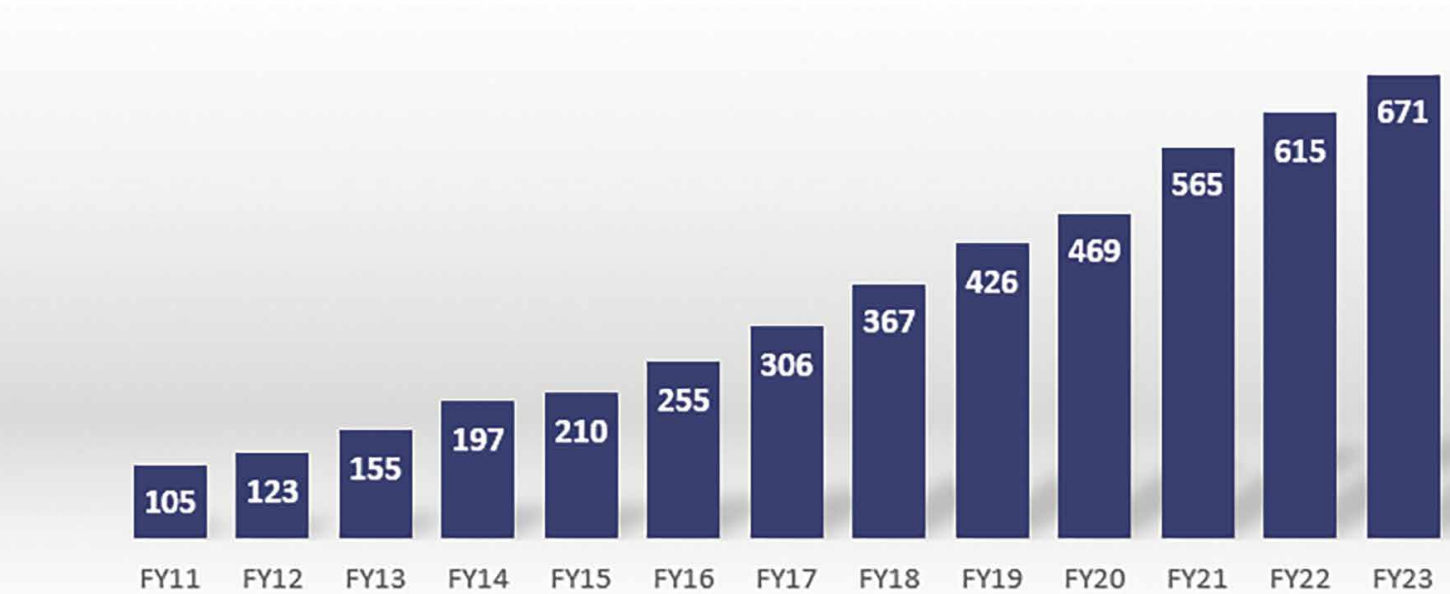
The Gift of Adoption network grew to 29 chapters with the addition of Virginia and Utah in Fiscal Year 2023.
