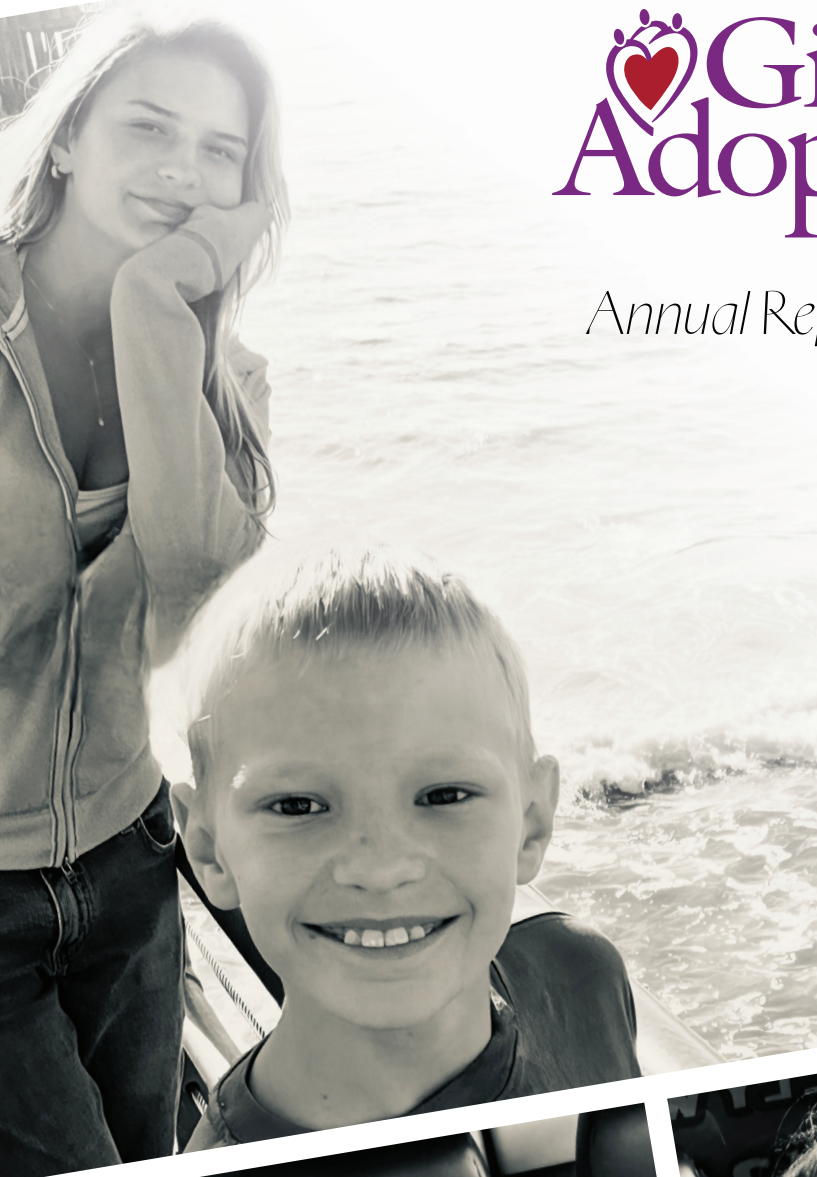


# 30 Years In

Dear Friends,

This year marks **30 years in.**

For three decades Gift of Adoption has stayed true to the belief that every child should grow up in a safe, permanent, and loving family. This belief inspires our progress.

**Measured** in Gift of Adoption's 4-star charity rating, expanded 30-chapter footprint, donor & leadership team retention, and in the \$23.7M in grants awarded to complete the adoptions of 7,011 children since our start in 1996.

**Seen and even felt** in the grant family stories we share. Impact stories like Rebecka's that tell how an aunt stepped in when her niece and two nephews were removed from their parent's care and separated from one another. Rebecka was able to adopt her youngest nephew, Luke (age six) into her family right away while his older siblings went to live in different foster homes. Over time, and after saving the money needed to buy a house that could hold this entire family together, Rebecka was in position to adopt Jolynn, her sixteen-year-old niece and Ledger, her nine-year-old nephew. The grant from Gift of Adoption provided the final funds needed to complete their adoptions and give the three siblings the security and belonging that comes from really and truly being 'home.' **Demonstrated** in a refusal to rest on our laurels; working to understand the complexity and scale of the gap we must bridge to eliminate financial barriers to adoption for the ~14,000 children living in vulnerable circumstances who are ready to be adopted into a U.S. family each year.

This progress drives our resolve. A resolve that is readily measured, seen and demonstrated in the generosity and love that you extend to Gift of Adoption and the children and families we are honored to serve. For this we are eternally grateful.

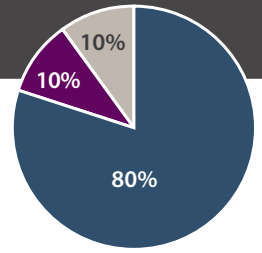

# 2025 PROGRAM ACCOMPLISHMENTS

## FOSTER CARE ADOPTION GRANTS

Gift of Adoption developed three new, discrete grant opportunities to help youth currently or formerly in foster care become adopted:

- » Grants to complete the adoptions of youth ages 18-21, formerly in foster care.
- » Licensing grants for relatives / fictive kin adopting family members out of foster care.
- » Grants to help families move from guardianship to adoption.



Through December 31, 2025 Gift of Adoption awarded 39 grants in these new categories to complete the adoptions of 57 children.

## TOTAL ADDRESSABLE NEED STUDY

A 2025 Total Addressable Need study conducted by L.E.K. Consulting substantiated that for vulnerable children eligible for adoption by U.S. families:

- » 14,000 children face financial barriers to adoption into U.S. families annually.
- » 4,000 children are being served by Gift of Adoption and peers each year.
- » 10,000 children remain unadopted each year.

Gift of Adoption is committed to closing the gap. By 2030 Gift of Adoption is committed to serving 1,200 children a year (up from 815 in 2025). This is the first milestone toward serving 50% of the total addressable need, so that, alongside our peers, we eliminate the financial barriers to adoption in the U.S. by 2045.

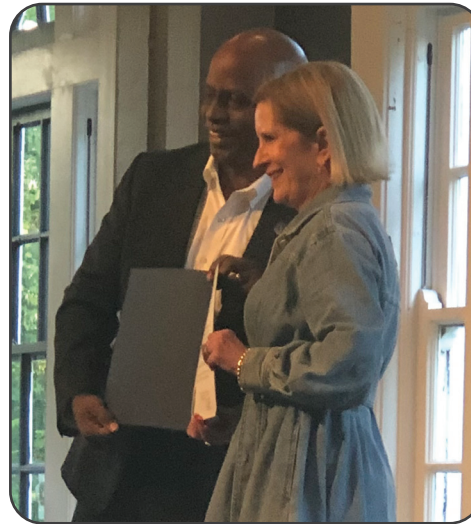
